Objectives: English III builds upon junior students' work in English I and II, with a significant emphasis on ACT Reading & English prep. Grammar, revision, punctuation, and reading comprehension are at the fore of this course. Students will read *The Crucible* by Arthur Miller and Shakespeare's *Hamlet*, in addition to culturally significant short stories throughout the year. Students are expected to complete independent work and be responsible for keeping up with deadlines and consistent weekly class assignments.

MS CCRS ELA Standards for English III:

The following standards offer a focus for instruction each year and help ensure that students gain adequate exposure to a range of texts and tasks. Rigor is also infused through the requirement that students read increasingly complex texts through the grades. Students advancing through the grades are expected to meet each year's grade-specific standards and retain or further develop skills and understandings mastered in preceding grades. The CCR anchor standards and high school grade-specific standards work in tandem to define college and career readiness expectations—the former providing broad standards, the latter providing additional specificity.

Reading Literature

Tests: Tests will occur regularly throughout the term. Tests are worth 55% of a student's grade. Common Term Assessments (CTAs) are worth 10% of a student's grade.

Retesting: Students will be allowed one retest per term. The student must reteach with Ms. Grammar after school prior to retesting. All retests must be completed within 10 school days of the original test. Students may not retest on CTAs.

Homework/Assignments/Projects: Students will have frequent homework assignments. It is a student's responsibility to keep up with all assignments given in-class and assigned for homework. Students will complete a final paper in Semester 2. This paper will be a significant portion of the student's grade.

Course Requirements: Students must complete all in-class and homework assignments as well as course tests at a 65% mastery to receive credit for the course.
